# Prostitution in Saarland

New rules for registration and duty to provide advice for sex workers

# Prostitution in Saarland

## **What's new?**

New legislation now requires anyone who works as a sex worker to register with the local authorities and to obtain advice on health issues first. Confirmation of the health consultation will be given, and is to be presented when you register. You must register in person, and this will also be confirmed. You must always carry both certificates with you. If you are unable to provide these certificates, or if they are invalid on presentation, you will be fined.

## **Who needs to register?**

The duty to register applies without exception to all people who provide sexual services in exchange for money.

## **How long are the certificates valid?**

People between the ages of 18 and 21 must extend their registration certificate after one year, and attend a health consultation every six months. For sex workers over the age of 21: The registration is to be extended after two years, the health consultation after one year.

## **Where do I register?**

People who will primarily be active in the Saarland must register with the "Regionalverband", the regional association, in Saarbrücken. If you have already registered in another Federal land, this registration will also be valid in Saarland.

## **What do I have to do?**

### **Step 1:**

Phone one of the numbers provided in this brochure for the Regionalverband Saarbrücken to arrange an appointment for your health consultation. You will receive confirmation that you have attended this health consultation which you need to present when you register.

### **Step 2:**

Make an appointment for your official registration with the Regionalverband, the regional association. This will take place in conjunction with an information and counselling interview.

What you need to bring when you register:

- **2 passport photos**
- **ID card, passport, replacement ID card or passport**
- **Foreign nationals who are not entitled to freedom of movement: Evidence of your permission to work in a profession or on a self-employed basis in Germany**
- **Confirmation of the health consultation (issued no more than 3 months ago)**

You will receive confirmation of registration. The fee for issuing the certificate of registration is **35 euros**.

**If required, the confirmation may also be made out in an alias. You may choose any alias you like.**
